Cookies

Data Storage

Data Security

TECDIGITAL has taken the necessary technical and organizational measures to adequately protect your data from unauthorized access and processing.

TECDIGITAL makes every reasonable effort to prevent unauthorized or unlawful use of the holder's personal data as well as its loss, destruction or damage. Where there is a leakage, loss or breach of personal data that could pose a high risk to the rights and freedoms of its users, TECDIGITAL will:

- Notify, within 72 hours of becoming aware of the incident, the supervisory authorities - National Data Protection Commission;
- Report the situation to the affected data subject (s) in good time.

TECDIGITAL guarantees the security of the holder's personal data through the following means: use of certified encryption in all communications of the website; use of restricted password to access the website; limitation of access to personal data.

Data Permanence

Your data will not be retained in our database longer than necessary for the purpose for which it was collected, unless we have to retain it for obligations and legal compliance.

How to Access and Control Your Personal Data
